- Valid driver's license.
- Ability to read and write English as required by RCW 41.14.100.
- Candidates must be able show proof of ability to type minimum 20 wpm.
- Meet Pacific County Sheriff Office's Employment Standards.

- Releasing prisoners
- Assisting in feeding prisoners
- Disciplining prisoners for violation of jail rules
- Supervising prisoner cell movement, recreation activities, chapel, special call-outs
- Transporting prisoners
- Completing reports, forms, etc.

All duties performed are in accordance with state law and departmental policies and procedures. Employees work with offenders in a potentially hazardous setting. Please consider this when deciding whether to apply.

# **Examination Process**

- An Oral Board Examination will be held for qualified applicants. The Oral Board examination will be conducted on **TBD** at the Courthouse Annex, 1216 W Robert Bush Drive, South Bend, WA 98586, unless otherwise specified.
- Ranking of the applicants shall be based on the results of the Oral Board's. A passing average of 30% is required.
- Veterans preference, as set out in RCW 41.04.005 and 41.04.010 shall be applied when entitled.
